Commercial Proposition

The platform will charge the fee directly to the respective banker availing the training services from FinBizness. Single package includes minimum 5 user logins and a minimum commitment of a year. The services will be activated 15 days from the date of payment.

Payment Options:

Payments will be accepted on an annual basis via NEFT/RTGS only. An additional facility of installment-based payment has been provided specifically for the co-operative bankers on a half-yearly basis.

Taxation:

As per government norms, the taxes applicable will be as follows:

- For banks based in Maharashtra: 9% CGST + 9% SGST
- For banks outside Maharashtra: 18% IGST

Content Provider:

Banking Frontiers is the content provider of the programs, FinBizness provides the technical platform for the training activities.

Topic Schedule:

Training topics will be announced on a weekly basis.

Mode of Delivery:

Training would be conducted by way of web streaming or webinar.

Responsibility of the Trainee:

The bank is responsible to have an internet connection with a speed of 256 Kbps to ensure proper relay of streaming.

- Each user will be provided a customized account and login credentials
